Operational and Financial Highlights

- Q1 generation 6% below budget

Investment Objective

The Company's aim is to provide investors with an annual dividend that increases in line with RPI inflation (6.94p for 2019) while preserving the capital value of its investment portfolio in the long term on a real basis through reinvestment of excess cashflow and the prudent use of gearing.

Investment Policy

- The substantial majority of the portfolio will be operating UK wind farms
- The portfolio will be invested in both onshore and offshore wind farms, with the amount invested in offshore wind farms being capped at 40% of GAV at acquisition
- The Company intends to retain exposure to UK power prices through Power Purchase Agreements ("PPAs") that avoid fixing the price of power
- The Company will generally avoid using non-recourse debt at wind farm level; total short term acquisition financing and long term debt at Company level will not exceed 40% of GAV at drawdown

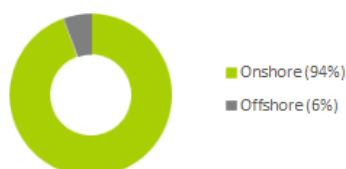
Portfolio

The portfolio comprises interests in 34 operating wind farms (950MW) plus 1 wind farm under construction (45MW). Key characteristics of the portfolio:

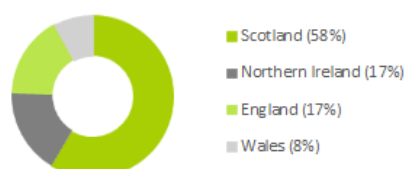
- Diversified geographical mix across England, Scotland, Wales and Northern Ireland

Operating Portfolio (by value)

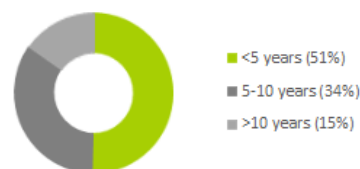
Onshore / Offshore



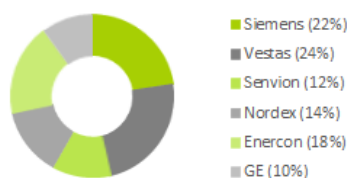
Geography



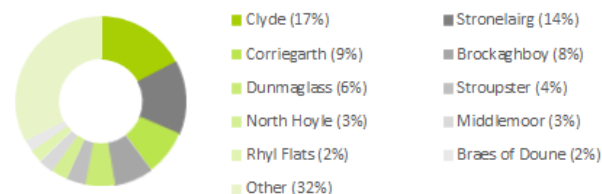
