Highlights

- Net cash generation of £118m despite Q1 generation 18% below budget (reflecting low wind resource)
- Payment of £56m dividend in respect of Q4 2024 (2.5p per share, bringing 2024 dividend to 10p)
- 1.2p decrease in NAV per share driven by lower power prices and movements in mark to market valuations of interest rate swaps, offset by robust net cash generation
- 13.4m shares bought back during the quarter at an average cost of 122p per share, adding 0.2p per share to NAV
- Aggregate Group Debt of £2,258m comprising £1,472m term debt + £270m drawn RCF at fund level + £516m share of Hornsea 1 debt, gearing at 40.2%

Investment Objective

The Company's aim is to provide investors with an annual dividend that increases in line with RPI inflation while preserving the capital value of its investment portfolio in the long term on a real basis through reinvestment of excess cash flow.

Investment Policy

The substantial majority of the investment portfolio will be operating UK wind farms. The Company intends to maintain a balanced exposure to power prices. Aggregate Group Debt will not exceed 40% of GAV at drawdown.


